RESOLUTION NO. 163

"WHEREAS, this Body in its session held on September 6, 1957, passed Resolution No. 166, a copy of which was furnished the Board of Liquidators, Manila, requesting said Board to defer collection of Ormoc City's indebtedness in the amount of P10,870.24 representing payment of one Tractor TD-14, one Truck-Tractor and one Trailer, until the next fiscal year;

"WHEREAS, the City Engineer, Ormoc City, in a letter to this Body dated September 17, 1957, recommended the immediate return of the aforementioned LASIDECO equipments because according to the same letter, the desire of the City Board for deferment of the return is not feasible; and

"WHEREAS, the fact that the city cannot afford to pay these equipments now, this Body agrees with the recommendation of the City Engineer to return the said equipments;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Gutierrez and Du;

"RESOLVED, as it is hereby resolved, to repeal Resolution No. 166 above mentioned, and do as this Body hereby, authorize the City Engineer, Ormoc City, to return the equipments in question to the Board of Liquidators or its authorized representative as soon as possible;


