RESOLUTION NO. 185

"WHEREAS, former Mayor Potenciano Larrazabal presented before this Board a voucher in his favor covering payment for commutation of vacation and sick leaves earned while Acting as City Mayor of Ormoc from October 10, 1955 to March 31, 1957, inclusive, or a period of 17 months and 22 days service with the corresponding accumulated vacation and sick leave of 44 days;

"WHEREAS, this Body sees that former Mayor Potenciano Larrazabal is rightfully and legally entitled to commutations of his vacation and sick leaves;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez and Vice Mayor Mejia;

"CARRIED UNANIMOUSLY."


