RESOLUTION NO. 186

"WHEREAS, former Mayor Potenciano Larrazabal, acting on a directive from Malacañang, suspended Chief of Police Ciriaco Porcadilla from office effective January 23, 1956, following a criminal case filed against the latter with the Court of First Instance at Ormoc City;

"WHEREAS, the said Court of First Instance in a decision promulgated on August 5, 1957 acquitted Chief of Police Ciriaco Porcadilla of the crime of Murder in Criminal Case No. 169-0 and also of the crime of Frustrated Murder in Criminal Case No. 212-0;

"WHEREAS, the dispositive portion of said decision of the Court of First Instance, aside from ordering the City Mayor to reinstate Ciriaco Porcadilla to his position as Chief of Police, also provides for the payment of all the salary pertaining to said office from the date of his suspension until the date when he is reinstated to said position; and

"WHEREAS, in view of the poor finances of the city government at present this Board can not possibly allow the payment of the back salaries of Chief of Police Ciriaco Porcadilla which amounts to over five thousand pesos, in lump sum; and

"WHEREAS, Vice Mayor Mejia manifested that in view of the inability of the city government to pay the back salaries of Mr. Porcadilla in one payment and in view also of the fact that there is no other remedy but to pay it by instalments, this Board allow the payment of the sum of ₱2,100.00 corresponding to seven months salary, the rest of the amount payable later;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla seconded by Councilors Ocubillo, Gutierrez, Penserga and Samson and Vice Mayor Mejia;


"RESOLVED, as it is hereby resolved, to allow a partial payment of the claim of Ciriaco Porcadilla for back salaries during the period of his suspension from January 23, 1956 up to the time of his reinstatement, hereby reverting for the purpose, the sum of ₱2,100.00 from out of the current appropriations for Election Expenses provided for in the city budget, corresponding to seven months of his back salaries, the balance payable later;
