"RESOLVED, as it is hereby resolved, to refer this aforestated claim of Mr. Celerino Baul to the City Attorney, Ormoc City, for legal opinion;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Attorney and the Fire Chief, all of Ormoc City.
