RESOLUTION NO. 188

"WHEREAS, Mr. Celerino Baul presented a voucher in his favor before this Board, covering payment of his salaries during the period of his suspension as Fireman of the Fire Department, this City;

"WHEREAS, Mr. Baul was suspended from office by former Mayor Potenciano Larrazabal following a criminal case filed against the said fireman with the Court of First Instance, this City; and

"WHEREAS, the said Court of First Instance acquitted Mr. Baul of the charges against him, hence his claim for back salaries; and

"WHEREAS, the dispositive portion of the decision of the case does not make mention of back salaries, unlike in the case of Chief of Police Porcadilla where it was specified in the decision that his back salaries should be paid, thus this Board is in doubt as to whether the claim for back salaries of Mr. Baul is legal or not;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Ocubillo and Parrilla;

"RESOLVED, as it is hereby resolved, to refer this aforesated claim of Mr. Celerino Baul to the City Attorney, Ormoc City, for legal opinion;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Attorney and the Fire Chief, all of Ormoc City.
