RESOLUTION NO. 192

"WHEREAS, the barrio people of Hibunawon, Ormoc City, have filed a petition with this Board requesting the opening of a vecinal road from said barrio to barrio Cabulihan along the national highway;

"WHEREAS, Hibunawon is an interior barrio with several inhabitants and which can safely be called an agricultural region considering the vast tract of corn and rice lands and sugar cane plantations all around;

"WHEREAS, this body has seen the real need of the said barrio to be connected with a road to the nearest point of the national highway in order to ease the transportation of the people's produce to the city; and

"WHEREAS, in view of the inability of the city to finance the construction of a feeder road to Hibunawon, the request and longings of the barrio people for a road can only be realized thru a national aid or thru an aid from the funds of the President;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Parrilla and Ocubillo;

"RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia to release from his contingent fund the amount of P20,000.00 for the construction of a feeder road from barrio Cagbuhangin to barrio Hibunawon;

"RESOLVED FURTHER, to indorse to His Excellency, the President of the Philippines, the original petition of the barrio people of Hibunawon for his consideration;

"RESOLVED FINALLY, to forward the original of this resolution to President Carlos P. Garcia, Malacañang, Manila, and that copies hereof furnished the Honorable City Mayor the barrio lieutenant of Hibunawon, both of Ormoc City.

"CARRIED UNANIMOUSLY."
