RESOLUTION NO. 196

"WHEREAS, last October 15, 1952 a contract and agreement had been executed by and between Acting City Mayor Marcelo Bandalan representing the City Government of Ormoc, and Mr. Basilio Codilla, of Valencia, Ormoc City, regarding the use of the latter's building for school purposes in Valencia;

"WHEREAS, Mr. Codilla's building was actually used and occupied by the city to house the intermediate classes of Valencia Elementary School from July 1, 1952 to January 31, 1953, utilizing three out of the four rooms of said building for two (2) grade five classes and one (1) grade six class;

"WHEREAS, for the use of said building, the contract and agreement further states, that the city government pay to Mr. Basilio Codilla the rental per month at P10.00 per room; and

"WHEREAS, until the present Mr. Codilla has not been paid the rentals corresponding to the period of occupancy of his building;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to revert from out of the current appropriation for election expenses provided for in the city budget, the sum of P160.00 or so much thereof as may be necessary, to cover payment of rentals of the building of Mr. Basilio Codilla in Valencia, Ormoc City, which was used by the city government to house the intermediate classes of Valencia Elementary School;



"CARRIED UNANIMOUSLY."


