RESOLUTION NO. 197

"WHEREAS, during the widening of city streets the city government used up the whole of Lot No. 577 under Original Certificate of Title No. 13691 in the name of Beatriz Velasquez and Victoria Velasquez, located along Lopez Jaena St. to widen said street, and Lot No. 751 under Transfer Certificate of Title No. 2480 in the name of the spouses Zoila Agoncillo and Salvador Sabello, located along Mabini St., to widen same street;

"WHEREAS, the area of these lots used by the government for road purposes are stated in their respective certificate of titles above-mentioned, to wit: Lot No. 577, 11 square meters; Lot 751, 37 square meters;

"WHEREAS, the owners of the lots above mentioned have made representations with this Board requesting that their lots be paid;

"WHEREAS, considering that this is an outstanding obligation of the city, and the fact that the said lots had been utilized by the government for many years now, this Board sees that the claims of the owners of the said lots are in order; and

"WHEREAS, considering further that these two lots are situated in different sections of the city - Lot No. 577 which is located along Lopez Jaena-Bonifacio Sts., a commercial section, while Lot No. 751 which is located along Mabini St., a residential section, this Body has decided to assign different values of these lots, to wit: Lot No. 577, at ₱25.00 per square meter; and Lot No. 751, at ₱15.00 per square meter;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to appropriate the amount of ₱830.00 from out of the salary savings of the positions of Senior Clerk in the Office of the City Auditor and Agricultural Adviser in the Office of the City Mayor which positions are incorporated in the current annual budget of Ormoc City, to be made available for the payment of the road right-of-way claims of Beatriz Velasquez and Victoria Velasquez, and the spouses Zoila Sabillo and Salvador Sabillo;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and each to the lot owners above mentioned, all of
