RESOLUTION NO. 198

"WHEREAS, a claim has been filed with this Board by members of the Police Force of this city in 1953 and whose services were terminated in 1954, for salary differential which were due them by virtue of the approval of the city budget for the fiscal year 1953-1954 which carried salary increases of these policemen; and

"WHEREAS, in view of the terminated of the services of these policemen early in 1954 while their appointments implementing the salary increases carried in the approved budget were still in Manila, these policemen were not able to collect their salary differential during that year; and

"WHEREAS, this Body sees that they are rightfully entitled to collect the said salary difference;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to revert the amount of P470.80 from out of the current appropriation for Election Expenses incorporated in the current annual budget, to be made available for the payment of the salary differentials of: Demetrio Tan, Andres Lureñana, Eleuterio Ablen, Francisco Tomada, Inocencio Cain, Solomon Sacay, Federico Castillo and Pablo Omega, all policemen of the city from 1953-1954;


