RESOLUTION NO. 200

"WHEREAS, one of the purposes for which the Secretariat of the League of Provincial Governors and City Mayors was organized is to have a staff of persons to follow up papers affecting local governments with the different offices of the national government at Manila; city

"WHEREAS, Ormoc is one who has important papers now pending in different offices of the national government in Manila, such as the following:

1. Resolution No. 152, series of 1957, reverting the amount of P1,440.00 from out of the current appropriation for discretionary fund of the City Mayor, for remittance as Ormoc City's contribution towards the maintenance of the League Secretariat, now in the office of the President of the Philippines awaiting approval;
2. The current annual budget of Ormoc City now in the Department of Finance also awaiting approval;
3. A requisition for firearms of the Ormoc City Police Department, now pending at Camp Crame.

"WHEREAS, this Body desires to avail of the services of the League Secretariat in order to facilitate the early approval of the above-enumerated papers which are awaiting approval in the different national offices as mentioned above;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to request the Secretariat of the League of Provincial Governors and City Mayors, Manila, to follow up and seek the immediate approval of the above-enumerated papers for Ormoc City;

"RESOLVED FINALLY, to furnish copies of this resolution each to Honorable Sergio Osmeña, Jr., Chairman of the League of Provincial Governors and City Mayors, Cebu City; the Honorable City Mayor, Ormoc City; and the City Treasurer, Ormoc City.


