RESOLUTION NO. 204

"WHEREAS, before the NWSA took over the control and coministration of the Ormoc City Waterworks System the city government, through a resolution passed by this Board, granted free water consumption to owners of the lots traversed by the wain pipe line of the said system;

"WHEREAS, this Board has information recently that the NWSA has cut off the privileges granted by the city government to the said land owners; and

WHERE I the giving of free water consumption to these landowners whose Linds have been traversed by the main pipe line of the Ormoc City waterworks System remains an obligation of the city government, and in view of the taking over of the administration and control of the said system by the MWNA, this Body is of the opinion that the NWSA should assume all the obligations of the city government as regards the operation of the city waterworks system;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to request the NWSA authorities to continue the granting of the privileges mentioned above, to the landowners whose lands have been traversed by the main pipe line of the Ormoc City Waterworks System;

"RESOLVED FINALLY, to furnish copies of this resolution each to the General Manager, National Waterworks and Swerage Authority, Manila; the Waterworks Supervisor, Ormoc City; the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
