RESOLUTION No. 205

"WHEREAS, Mr. Jose Esmero was appointed Member of the Secret Service Division, Police Department, Ormoc City, on March 13, 1954 and has served as such continuously until his services were terminated on November 15, 1955;

"WHEREAS, upon his termination from office Mr. Esmero was entitled accumulated vacation and sick leave for 51 days with a money value of ₱132.90 which he failed to collect during that time and still remains uncollected until the present;

"WHEREAS, said Mr. Esmero has been making representations with this Body asking that he be paid the money value of his accumulated leaves as former member of the police department; and

"WHEREAS, this Body, considering that Mr. Esmero was separated from the service not through any fault of his own, sees that his claim is legal and in order;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Du and Gutierrez;

"RESOLVED, as it is hereby resolved, to revert from out of the current appropriations for Election Expenses provided for in the budget, the sum of ₱132.90 to be made available for the payment of the accumulated vacation and sick leaves of Mr. Jose Esmero, a former member of the Police Department, Ormoc City.


