RESOLUTION NO. 208

"WHEREAS, the Police Department, Ormoc City, is one department of the city government with quite a number of personnel under it, the actual force at present numbering sixty-four including the Chief;

"WHEREAS, aside from the City Mayor who is the over-all commander of the Police Department, the Chief of Police is not paired with another officer to share in the administrative functions of said department; and

"WHEREAS, due to exigencies of the service this Body sees the necessity of creating the position of Assistant Chief of Police ;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;


"RESOLVED, as it is hereby resolved, to create the position of Assistant Chief of Police in the Police Department, Ormoc City, with compensation at the rate of P1,800.00 per annum effective as of the 25th day of October, 1957;


"RESOLVED FURTHER, to appropriate from out of any funds existing in the city treasury not otherwise appropriated, the sum of P1,233.87 or so much thereof as may be necessary, to carry out the provisions of this resolution from October 25, 1957 to June 30, 1958;


