"HEREA) due to exigencies of the service this Body sees the necessity of creating the position of Assistant Chief of Police ;

"MESOLVED, as it is hereby resolved, to create the position of Assistant Chica of Police in the Police Department, Ormoc City, with compensation at the rate of Fl,800.00 per annum effective as of the 25th day of October, 1957;

"RESOLVED FURTHER, to appropriate from out of any funds existing in the city treasury not otherwise appropriated, the sum of ₱1,233.87 or so much thereof as may be necessary, to carry out the provisions of this resolution from October 25, 1957 to June 30, 1958;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City;

"CARRIED UNANIMOUSLY."
