RESOLUTION NO. 212

"WHEREAS, this Body in its regular session held on September 27, 1957, passed Resolution No. 182, reverting from out of the current appropriations for the purchase of a school site for the Ormoc City High School, the amount of ₱617.50 for the payment of salary of Miss Conchita A. Go from June 23, 1956 to November 3, 1956, as classroom teacher of said school;

"WHEREAS, the Division Superintendent of Schools in a 2nd indorsement relative to the matter, objected as "unwise" to the charging of the back salaries of Miss Go to the City High School Site Fund, adding that the amount is not even enough to purchase the required 3-hectare site that the high school badly needs;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to amend Resolution No. 182, c.s., of this Board, so that the appropriations carried therein be charged against the current appropriations for Election Expenses provided for in the current annual budget, instead of from the Ormoc City High School Site Fund, as originally appropriated;



"CARRIED UNANIMOUSLY."


