RESOLUTION NO. 226

"WHEREAS, one Mr. Panfilo V. Polido filed a claim with this Board for payment of his accumulated vacation and sick leave as City Janitor-watchman in Liloan Elementary School from December 1, 1950 to June 30, 1951;

"WHEREAS, when Mr. Polido's position was abolished due to lack of funds on July 1, 1951, he was accredited 18 days of vacation and sick leave at P70.00 per month which he was not able to collect for lack of funds at that time, with a money value of P40.65;

"WHEREAS, this Board sees no reason why such a legal claim as this should be denied;


"NOW, THEREFORE, the Board on motion of Councilor Marciano S. Du seconded by Councilor Emilio C. Penserga;

Polido, a former City Janitor-Watchman at Liloan Elementary School, Ormoc City;


"RESOLVED FINALLY, to furnish copies of this Resolution each the Division Superintendent of Schools, Tacloban; the Honorable City Mayor, the City Treasurer, the City Auditor, the City Supervisor, District I, and Mr. Panfilo V. Polido, all of Ormoc City.

"CARRIED UNANIMOUSLY."


