"RESOLVED, as it is hereby resolved, to give the authority of allocating the troughs in the newly constructed public market buildings to the Honorable City Mayor, and for him to formulate rules and regulation regarding the same;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the Market Superintendent and the City Health Officer, all of Ormoc City.

"CARRIED UNANIMOUSLY."




