- 1. The proposed source has sufficient discharge and elevation (in relation to the barrio proper) to warrant the construction of a water system;
- 2. The main line will have a length of 1000 meters while the distrivution system will be 500 meters; and
- 3. Per rough estimates of this Office, the proposed system will cost \$10,000.00.

"BE IT RESOLVED, as is hereby resolved, to request the General Manager of the National Waterworks and Sewerage Authority; Manila, to appropriate the amount of TEN THOUSAND PESOS (\$10,000.00) for the construction of the Margen Waterworks System in the City of Ormoc as has been already surveyed and favorably recommended by the Waterworks Supervisor, Engr. Nestor C. Penserga, of this City;

"RESOLVED FINALLY, to furnish copy of this resolution each to the General Manager of the National Waterworks and Sewerage Authority, the Honorable Executive Secretary, and the Honorable Secretary of Finance, all of Manila; and to the City Mayor, the City Engineer, the City Treasurer, the City Auditor, the Waterworks Supervisor, all of Ormoc City;
