RESOLUTION NO. 235

"WHEREAS, Fireman Timoteo Aparis has assumed office as such effective November 16, 1957, vice Bernardo Arcuino, resigned;

"WHEREAS, payment of Fireman Timoteo Aparis' services could not be passed in audit because, according to the City Auditor, the former fireman (Bernardo Arcuino) has collected the money value of his 96 days (November 16, 1957 to February 19, 1958) accumulated vacation and sick leaves in the amount of ₱220.86;

"WHEREAS, Councilor Guillermo T. Parrilla suggested that in order to avert further suspension by the City Auditor for the succeeding months it is necessary to appropriate the amount of ₱220.86 for the salary of Fireman Timoteo Aparis from November 16, 1957 up to and including February 19, 1958 to be taken from out of the Election Expenses Fund;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Inaki A. Larrazabal;



"RESOLVED FURTHER, to request the City Treasurer to make a supplemental budget for the foregoing appropriation;


