We are lucky to have been allocated one Station  
Wagon for the use of the Department of Health this  
city after vigorous efforts have been exerted in ob-  
taining this station wagon which the Health Department  
needs very badly.

There is only one condition given and that is a  
Resolution of the City Council setting aside the amount  
of ₱1,200.00 per annum payable from the Health Fund as  
yearly expenditure for the maintenance and operation of  
such vehicle, duly certified by the City Treasurer and  
verified by the City Auditor, be made and will be sub-  
mitted to the Director of Health so that this Station  
Wagon will be permanently given to Ormoc City Health  
Department.

It is hoped that the City Council will be consi-  
derate enough in making this resolution thinking of  
the advantages for Ormoc City in being given a Station  
Wagon worth ₱8,000.00.



"CARRIED UNANIMOUSLY."


