RESOLUTION NO. 238

"WHEREAS, by virtue of Resolution No. 237, current series, the Board created the position of DRIVER in the Office of the City Health Officer, Ormoc City, with compensation at the rate of One Thousand Two Hundred Pesos (P1,200.00) per annum;

"WHEREAS, the amount of One Thousand Two Hundred Pesos is not yet covered by appropriation in the current fiscal budget;

"WHEREAS, the Board deems it necessary to appropriate the amount of Six Hundred Fifty Pesos (P650.00) to pay the driver for the period beginning December 16, 1957 up to and including the end of the fiscal year, June 30, 1958, to be taken from out of the Election Expenses Fund;

"NOW, THEREFORE, the Board, on motion of Councilor Iñaki A. Larrazabal, seconded by Councilor Teotimo P. Ocubillo,


"BE IT RESOLVED, as is hereby resolved, to appropriate the amount of Six Hundred Fifty Pesos (P650.00) to pay the driver of the Office of the City Health Officer for the period beginning December 16, 1957, up to and including the end of the fiscal year, June 30, 1958, at the rate of One Thousand Two Hundred Pesos per annum, to be taken from out of the Election Expenses Fund;

"RESOLVED FURTHER, to request the City Treasurer to make a supplemental budget for the foregoing appropriation;


"RESOLVED FINALLY, to furnish copy of this resolution each to the Director of Health, Manila; and to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Health Officer, all of Ormoc City.

"CARRIED UNANIMOUSLY."


