RESOLUTION NO. 241

Letter of the City Caterer, Ormoc City, quoted
verbatim hereunder as follows:

"Ormoc City
November 18, 1957

Hon. Esteban Conejos
City Mayor
Ormoc City

S i r :

I regret very much to inform the Mayor that my previous bid at ₱.40 per prisoner per day is a losing proposition. At the end of every quincena, I found, to my regret, that the amount I collected from the City Government is not even enough to pay for my debts in milled corn and viands for the preceding quincena in spite of good care I took in the preparation and in handling of foodstuffs.

As the Contract for the subsistence of prisoners is for one year, I respectfully request His Honor, to suspend the contract and to run the prisoners' mess under administration. Sixty centavos (₱.60) per prisoner per day is sufficient.

In order that I may recover my losses, I wish to apply as manager for the preparation of the prisoners' subsistence even as a gesture of rewards for my long experience and services in the maintenance of prisoners.
