As what I have observed in the city of Manila, Trafficmen during Sundays and holidays are wearing this kind of uniform and it is more attractive to the public.

It is therefore, requested that the Honorable City Council shall consider this matter and appropriate the amount of ₱300.00 to cover the expenses of the aforesaid uniform.




