"WHEREAS, in token of the love of Ormoc City for a beloved son who has made good in his profession and in his political carrier;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Tan, Jr.;

"CARRIED UNANIMOUSLY."


