RESOLUTION NO. 2

"WHEREAS, the Ormoc Electric Company is charging P0.40 per kilowatt for the first 15 kilowatts of consumption, P0.30 per kilowatt for the succeeding 10 kilowatts, and P0.25 per kilowatt for the next 50 kilowatts;

"WHEREAS, this rate per kilowatt which the Ormoc Electric Company is charging its consumers has been the same rate they had been collecting for the past several years;

"WHEREAS, this Body had information that several electric companies throughout the Philippines have reduced their rates per kilowatt, like the Manila Electric Company who has reduced its rate by 16%, the electric company in Cagayan de Oro which has reduced its rate at the start of this new year;

"WHEREAS, the present rate at which the Ormoc Electric Company is charging its consumers is very high and, probably it is the highest throughout the Philippines;

"NOW, THEREFORE, the Board, on joint motion by Councilors Ocubillo and Du, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to request the Public Service Commission, Manila, to order the Ormoc Electric Company, Ormoc City, to lower its present rate so that the people will be relieved of paying a very high rate which is now imposed by the said company upon its consumers;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Public Service Commission, Manila; Aboitiz & Co., Cebu City; the President of the Philippines, Malacañang, Manila; the Committee on Franchises, House of Representatives, Manila; and Congressman Dominador M. Tan, House of Representatives, Manila.
