WHEREAS, in the prosecution of the criminal case against Ignacio Cañezo, Alberto Arradaza and others in the Court of First Instance, Ornec City, the PC Company at Ornec City took from the Police Department two .38 cal. revolvers, Smith and Wesson, police positive, which they used as exhibits, these revolvers having allegedly been used by the two persons above mentioned, both of whom were policemen, at the shooting in the eve of the 1953 Trasidential elections?

"WATERAS, inasmuch as the case has already been terminated, this body believes that the holding of the said side arms by he 59th PC Company is no longer necessary; and

"WHIREAS, the Ormoc City Police Department is in dire need of side arms, as a matter of fact there are still a number of city policemen who are unarmed until the present;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Larrazabal;

"REED LVED, as it is hereby resolved, to request the 59th PC Company, Ormoc City, thru its Commanding Officer, to return to the Ormoc City Police Department the two side arms above mentioned, for the reason that the Police Department is badly in need of these firearms;

"RESOLVED FINALLY, to furnish copies of this resolution each to the PC Provincial Commander, Camp Bumpus, Tacloban City; the Commander, III Military Area, Cebu City; and the Commanding Officer, 59th PC Company, Camp Downes, Ormoc City.

"CARRIED UNANIMOUSLY."
