RESOLUTION NO. 10

"WHEREAS, this Board passed Resolution No. 176, series 1957, requesting His Excellency, President Carlos P. Garcia to give an aid of ₱20,000 from out of his contingent fund, for the construction of a sea wall along the shore of barrios Alegria, Punta and Batuan, Ormoc City;

"WHEREAS, a copy of said resolution was furnished the Honorable Secretary of Public Works and Communications and the Director of Public Works;

"WHEREAS, the Director of Public Works in a letter to this Board dated November 18, 1957 requested the submission of the necessary data for the proposed sea wall;

"WHEREAS, the City Engineer has now submitted the socio-politico economic factors affecting priority of the proposed project and its layout sketch; and

"WHEREAS, with the submission of the complete data required, this Body believes that investigation and survey, preparation of the plans and estimates and everything preparatory to the start of the construction of the proposed project would then be in order;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilors Larrazabal and Du;

"RESOLVED, as it is hereby resolved, to request His Excellency, President Carlos P. Garcia, to release as early as possible, the amount of ₱20,000 from out of his contingent fund in order to start the construction of the proposed sea wall above mentioned;

"RESOLVED FINALLY, to furnish copies of this resolution each to Congressman Dominador M. Tan, House of Representatives, Manila; the Secretary of Public Works and Communications, Manila; the Director of Public Works, Manila; and the City Engineer, Ormoc City.

"CARRIED UNANIMOUSLY."
