RESOLUTION NO. 11

"WHEREAS, at present there are only very few of the 57 bar-  
rios of Ormoc City which have artesian wells;

"WHEREAS, requests have been filed with this Board from these  
barrios asking that they be privileged with the facilities of a  
sufficient source of water supply just as the other barrios are; and

"WHEREAS, this Body has observed that of the several barrios  
in Ormoc City that lack an adequate water supply, there are some  
30 of them most needy and warrants immediate attention;


"NOW, THEREFORE, the Board, on motion of Councilor Tan, Jr.,  
seconded by Councilors Du and Parrilla;

"RESOLVED, as it is hereby resolved, to request the National  
Waterworks and Sewerage Authority, Manila, to allocate for Ormoc  
City, 30 more artesian wells, the site at which these wells will  
be dug to be determined by this Board and to be distributed in  
most needy barrios;


"RESOLVED FINALLY, to furnish copies of this resolution each  
to the General Manager, National Waterworks and Sewerage Authority,  
Manila; the Waterworks District Engineer, Tacloban City; the City  
Mayor and the City Engineer, both of Ormoc City.

"CARRIED UNANIMOUSLY."


