"WHEREAS, this election has for the first time projected a native Leyteño into national prominence by virtue of his holding the fourth highest position in the Philippine Government;

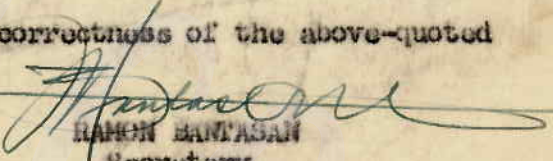
NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Vice Mayor Mejia and all the City Councilors;

"CARRIED UNANIMOUSLY."

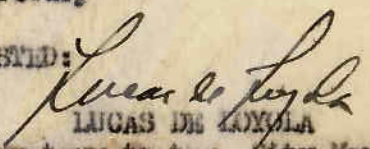
