RESOLUTION NO. 15

"WHEREAS, this Board passed Resolution No. 189, s. 1955, in authorizing the City Mayor to sign or enter into a contract, on behalf of the city government, with Mr. Antonio B. Tan for the use of the city of a piece of land used as airstrip in Cogon Combado;

"WHEREAS, the same resolution above mentioned also authorized an annual rental of P30.00 for the said land;

"WHEREAS, this Body understands that until the present said contract has not as yet been executed in view of the fact that the term or life of the contract has not expressly been provided in the aforementioned resolution;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Larrazabal;

"RESOLVED, as it is hereby resolved, to request the City Attorney, Ormoc City, to draft and prepare the contract between the City Mayor in behalf of the city government and Mr. Antonio B. Tan, for the sub-leasing of the latter's land used by the city as airstrip in Cogon Combado, and that the life of the contract should be four (4) years from January 1, 1958.

"CARRIED UNANIMOUSLY."


