## RESOLUTION NO. 15

"WHEREAS, this Board passed Resolution No. 189, s. 1955; n authorizing the City Mayor to sign or enter into a contract/be-half of the city government, with Ar. Antonio B. Tan for the use of the city of a piece of land used as airstrip in Cogon Combado;
