RESOLUTION NO. 19

"WHEREAS, in the current annual budget of Ormoc City which is now pending approval in the Department of Finance, Manila, there is incorporated and proposed to be created the position of City Librarian;

"WHEREAS, in a letter to this Board dated December 11, 1957, the Department of Finance through the Honorable Undersecretary Jose P. Trinidad disapproved the said proposal to create the position of City Librarian in Ormoc City; and

"WHEREAS, this Body considers the said position of City Librarian as very essential because if there is no one to take charge of the City Library which is now in smooth operation, the City will lose all the books and other reading materials allocated to Ormoc City by the Bureau of Public Libraries, the United States Information Service and other sources, thus depriving the reading public of vital information and knowledge of events necessary to strengthen the morale of the public in general;

"WHEREAS, this Body has by a resolution passed in its regular session on January 17, 1958, requested for the reconsideration and approval of the positions of three market collectors, one stenographer in the Office of the City Attorney, one janitor-messenger in the City Library and one agricultural adviser and fertilizer in-charge in the Office of the City Mayor, all these positions incorporated and proposed to be created in the current annual budget of this City and mentioned as disapproved in the above-mentioned letter to this Board dated December 11, 1957 by the Honorable Undersecretary of Finance; and

"WHEREAS, through inadvertence or oversight this Body has failed to mention in the said resolution requesting for reconsideration of the positions mentioned in the next preceding paragraph, the position of the City Librarian which is more important and essential than the Janitor-messenger in the City Library;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Tan, Jr.;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to request the Honorable Secretary of Finance, Manila, to reconsider and approve the position of City Librarian at Ormoc City, for the reason that the said position is urgently needed and very essential in order not to disrupt the operation of the City Library and for the welfare of the public in general;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable Secretary of Finance, Manila; the Director of Public Libraries, Manila; and Congressman Dominador M. Tan, House of Representatives, Manila.

"CARRIED UNANIMOUSLY."


