"WHEREAS, the Honorable City Mayor has delegated Vice Mayor Mejia as chairman of said delegation and Councilors Jorge P. Tan, Jr. and Teotimo P. Ocubillo as members;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Tan, Jr.;

"CARRIED UNANIMOUSLY."


