RESOLUTION NO. 21

"WHEREAS, in a letter to this Board dated February 20, 1958, the City Attorney urged this Body to find ways and means to supply a bond of ₱16,000.00 to "pay for the damages which the Petitioners may suffer by reason of the withholding of the Writ and in maintaining the status quo of the parties during the pendency of the case", said case now pending in the Court of First Instance, Ormoc City, entitled Daciano Palami, et al, versus Potenciano Larrazabal, et al, docketed as Special Civil Action No. 135-0;

"WHEREAS, this Board deems it necessary to file said counterbond with properties of the City to sustain the Mayor, the Treasurer and the Auditor who were made respondents to the case as a result of the abolition by the Board of the positions of the petitioners in the city government;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Tan, Jr.;


"RESOLVED, as it is hereby resolved, to authorize the City Attorney and the City Treasurer to prepare a counterbond in the amount of ₱16,000.00 of the properties of the City, and offer said bond to the Court of First Instance where the case mentioned above for which this bond is to be filed, is pending;

"RESOLVED FURTHER, to authorize the City Mayor to sign for any property offered by the City as counterbond in said case;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Attorney, the City Treasurer and the City Auditor all of Ormoc City.

"CARRIED. Five affirmative votes, no negative vote and three abstentions."


