RESOLUTION NO. 2

"WHEREAS, during this session the Market Superintendent, Mr. Eleuterio Cadiben requested the Board that he be furnished 100 feet of water hose in order to maintain sanitation in the public market and another 50 feet for the slaughterhouse;

"WHEREAS, Mr. Cadiben further reported that the Waterworks Supervisor had commented on the unnecessary wastage of water in the slaughterhouse due to a defective faucet which needs replacement; AND

"WHEREAS, Mr. Cadiben manifested furthermore, that he has prepared requisitions for all these items but that the same needs an appropriation where they can be purchased;

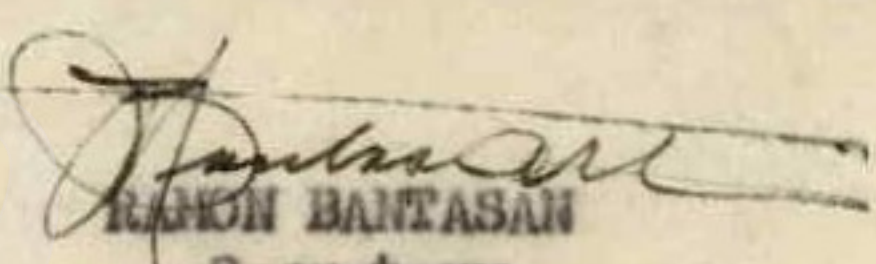
"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilors Tan, Jr., and Ocubillo;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P120.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the purchase of 100 feet of water hose for the public market, and another 50 feet for the slaughterhouse; and appropriating further the amount of P3.50 from the same source, for the purchase of one faucet for the slaughterhouse;

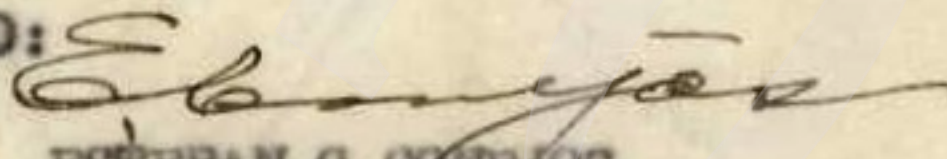
"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Market Superintendent all of Ormoc City.

"CARRIED UNANIMOUSLY."

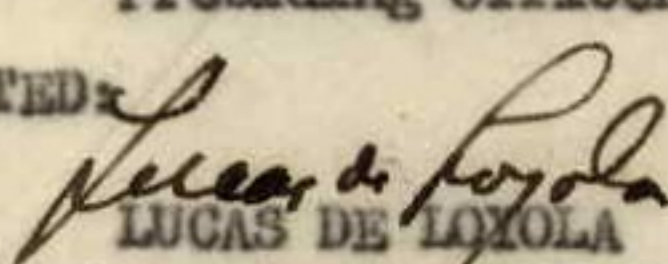
