RESOLUTION NO. 20

"WHEREAS, the City Engineer and the City Treasurer have approved a claim for payment of meal allowances in lieu of overtime pay for overtime services rendered by Project Inspector Ruben Penserga in connection with the construction of the market buildings;

"WHEREAS, the City Auditor, Ormoc City, in a tentative suspension attached to the voucher stated that the same can not be allowed in audit in view of a standing auditing regulation that overtime service pay requires the approval of the President with the proper recommendation of the head of the Office; and

"WHEREAS, this Board concurs in the opinion of the City Engineer embodied in a 6th indorsement dated October 24, 1957 relative to the matter, that the authority to approve meal allowances relative to the inspection and supervision of the construction of the Ormoc Market Buildings, a purely city project, shall emanate from the City Chief Executive with the approval of this Board;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to approve the afore-stated claim for meal allowances in lieu of overtime pay of Project Inspector Ruben Penserga, and to authorize the payment same, hereby appropriating the sum of P8.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the purpose;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer and Project Inspector Ruben Penserga, all of Ormoc City.
