
NOW, THEREFORE, on motion of Councilor Du, seconded by Councilors Tan, Jr., and Parrilla;

"RESOLVED, as it is hereby resolved, to declare as first class, the above roads and streets for Ormoc City, as per recommendation of the City Engineer;




