"WHEREAS, records in the City Treasurer's office show that the amount appropriated for traveling expenses for the Office of the City Mayor has already been exhausted; and

"WHEREAS, this Board considers it most advantageous to have Ormoc City represented by the Honorable City Mayor in said convention;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to authorize the Honorable City Mayor to proceed to Manila to attend the forthcoming convention of Provincial Governors and City Mayors and to follow up official matters concerning the city government of Ormoc in Manila, hereby appropriating for the purpose, the amount of P500.00 from out of any funds existing in the city treasury not otherwise appropriated.

"CARRIED UNANIMOUSLY."


