RESOLUTION NO. 33

A RESOLUTION REQUESTING THE NATIONAL CIVIL DEFENSE ADMINIS-
TRATION TO ALLOCATE FOR ORMOC CITY SIX (6) JEEPS FROM
OUT OF THE JAPANESE REPARATIONS

"WHEREAS, this Board has learned from the papers that there are jeeps equipped with radio coming to the Philippines from the Japanese Reparations;

"WHEREAS, this Board has learned further, that the national government of the Philippines will distributed the said jeeps to government branches and instrumentalities in its campaign for peace and order, for the collection of taxes and other purposes necessary to carry out the functions of government; and

"WHEREAS, Ormoc City is in dire need of transportation facilities to be furnished to the different departments of the city like the Police Department for the maintenance of peace and order, the Fire Department to transport personnel and equipment to the scene of fire in case of one, the City Treasury for the collection of taxes, the City Auditor for going out to inspect government projects and employees working in such projects and the rest of the departments;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to request the National Civil Defense Administration, Manila, to allocate for Ormoc City six (6) radio-equipped jeeps from the Japanese Reparations for the city departments of Ormoc City;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Administrator, National Civil Defense Administration, Manila; the President of the Philippines, Malacañang, Manila; Congressman Dominador M. Tan of the 2nd District of Leyte, now in Manila; and the Reparations Commission, Manila.

"CARRIED UNANIMOUSLY."
