RESOLUTION NO. 34

"WHEREAS, the City Engineer in a letter to this Board dated March 13, 1958, has informed that the bidding for the construction of the proposed slaughterhouse and market tienda at Bos. Alegria and Valencia, respectively, has already been finished, and requested that the award of contract be given to either Mr. Fortunato Sanchez of Butuan City or Mr. Antolin A. Jariol of Cebu City;

"WHEREAS, this Board has already been convinced of the workmanship of Mr. Jariol with his completion to the full satisfaction of this Body, of the recently finished market buildings, of which he was the contractor; and

"WHEREAS, this Board has been made to understand that Mr. Antolin A. Jariol is willing to reduce his bid by P500.00;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Larrazabal;

"RESOLVED, as it is hereby resolved, to award the contract for the construction of the proposed slaughterhouse in Bo. Alegria and the proposed market tienda at Bo. Valencia, to Mr. Antolin A. Jariol, provided he will reduce his original bid price by P500.00;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer and the City Health Officer, all of Ormoc City; and to Mr. Antolin A. Jariol, 2nd Floor, Quirino Rodriguez Bldg., Cebu City.

"CARRIED. Eight affirmative votes, one negative vote."


