\$100.00 - to be paid to Dr. Alvaro I. Gutierrez for professional services and to pay for the cost of confinement; and

15.50 - to be reimbursed to Pat. Codilla for medicines bought by him during his treatment.

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.
