RESOLUTION NO. 35

"WHEREAS, a member of the Police Force, this City, Pat. Mauricio Codilla, was confined in the Sacred Heart Hospital for treatment of wounds inflicted upon him during a scuffle while he was performing his duty as policeman;

"WHEREAS, for his confinement in the said hospital, his attending physician, Dr. Alvaro I. Gutierrez, charged him P100.00 for professional services and the cost of confinement, aside from his (Codilla's) personal expenses amounting to P15.50 for the purchase of medicines used during his treatment; and

"WHEREAS, it is the opinion of this Board that such expenses be borne by the City government, in view of the fact that Pat. Codilla sustained the wounds while on official duty;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P115.50 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the cost of hospitalization of Pat. Mauricio Codilla, itemized as follows:


- P100.00 - to be paid to Dr. Alvaro I. Gutierrez for professional services and to pay for the cost of confinement; and
- 15.50 - to be reimbursed to Pat. Codilla for medicines bought by him during his treatment.


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.
