RESOLUTION NO. 36

"WHEREAS, in a letter dated March 28, 1958, Supervising Veterinarian Tomas E. Rodica informed this Board that at present there is an outbreak of hemorrhagic septicemia, a disease among cattle and carabaos, in Ormoc City;

"WHEREAS, in the same letter, the said supervising veterinarian requested an appropriation for the purchase of medicines, gasoline, and vaccines needed for the immunization of said animals;

"WHEREAS, this Body, considering that to protect the lives of these work animals above mentioned would be to the best interest of the people in general, deems it wise to give the requested amount;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P200.00 from out of any funds existing in the city treasury, not otherwise appropriated, to be made available for the purchase of medicine and gasoline, in connection with the campaign for the treatment of sick cattle and carabaos in Ormoc City;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Director of Animal Industry, Manila; the Regional Veterinarian, and the Supervising Veterinarian, Tacloban City; the City Treasurer and the City Auditor, both of Ormoc City.
