RESOLUTION NO. 39

Letter of the Chief of Police, Ormoc City, dated January
29, 1958, quoted verbatim hereunder, reads:

The Honorable Municipal Board
Thru: The Honorable City Mayor
Ormoc City

Sir:

I have the honor to request the Honorable Municipal Board to
intercede in behalf of this department for the procurement of four
(4) riot shotguns 12 gauge in the form of a loan from the Provincial
Headquarters PC Leyte Province. Aforesaid shotguns are presently
under the accountability of the Commanding Officer, 59th PC Company,
Camp Downes, Ormoc City.

These riot guns shall be exclusively used by jail guards, build-
ing guards, prisoners guard at work, escorts of prisoners facing trial
at CFI which are more effective than a revolver while on such routine
duties.

This department is presently in need of these arms, hence the
foregoing request as twenty-six (26) more members of this department
have no corresponding arms for security while in the performance of
their official duties.

"WHEREAS, the use for which the riot guns are requested are
clearly stated in the above-quoted letter;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to request the PC Provincial Commander, Tacloban City, to loan to the Ormoc City Police Department four (4) riot guns as requested by the Chief of Police in order to avoid jail breaks and other happenings which might be prevented by the use of these weapons;

"RESOLVED FURTHER, to request the PC Provincial Commander, to provide each gun with 100 rounds of ammunition;


"RESOLVED FINALLY, to furnish copies of this resolution each the PC Provincial Commander, Tacloban City; the 59th PC Company Commanding Officer, Camp Downes, Ormoc City; and the Chief of Police, Ormoc City.

"CARRIED, Unanimously."


