RESOLUTION NO. 40

"WHEREAS, one ^{Eugenio R} ~~Eulogio~~ Caberos has made known his intention before this Board thru Councilor Parrilla, to establish and operate a radio broadcasting station in Ormoc City;

"WHEREAS, according to applicant Caberos, he has already acquired and paid for a complete set of equipment and apparatus necessary for the purpose, but that the same will not be released to him without first securing a permit or franchise to operate and maintain said radio broadcasting station; and

"WHEREAS, this Board sees that it would be to the best interest not only to the residents of Ormoc City but also to the neighboring towns and provinces if a radio broadcasting station can be established and operated in Ormoc City;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Ocubillo and Tan, Jr.;

"RESOLVED, as it is hereby resolved, to request Congressman Dominador M. Tan of the 2nd District of Leyte, House of Representatives, Manila, to secure or cause to be issued, a franchise for the establishment, operation and maintenance of a radio broadcasting station in Ormoc City, in favor of ^{Eugenio R} ~~Eulogio~~ Caberos;


"RESOLVED FINALLY, to furnish a copy of this resolution to Mr. ^{Eugenio R} ~~Eulogio~~ Caberos, Radio Operator, Davao Penal Colony, Davao City.

"CARRIED, Unanimously."


