RESOLUTION NO. 42

"WHEREAS, there is a surplus of about P40,000.00 out of the
P100,000.00 loan from the RFC for the construction of the new
public market buildings in Ormoc City;

"WHEREAS, the City Government of Ormoc is proposing to create
or construct a public market building in barrio Valencia and a
slaughterhouse in Alegria out of the said surplus amount; and

"WHEREAS, the plans and specifications of the above mentioned
projects are already completed and ready for execution;

"NOW, WHEREFORE, the Board, on motion of Councilor Penserga,
seconded by Councilors Parrilla and Ocubillo;

"RESOLVED, as it is hereby resolved, to revert the surplus
amount of the P100,000.00 loan from the RFC for the construction
of the new market buildings in the poblacion, Ormoc City, for the
construction of the proposed market building in barrio Valencia
and the proposed slaughterhouse in barrio Alegria, both of this
City;

"RESOLVED FINALLY, to furnish copies of this resolution each
to the Rehabilitation Finance Corporation, Manila; the City Treas-
urer, the City Auditor and the City Engineer, all of Ormoc City.
