RESOLUTION NO. 45

"WHEREAS, this Board has been informed thru a statement from the Office of the City Treasurer, this City, that the Discretionary Fund of the City Mayor and also item C-1-c of the same office, have red balances on their accounts, meaning that these accounts have incurred overdrafts;

"WHEREAS, the Honorable City Mayor has requested this Body to appropriate the amount of P1,300.00 for the discretionary fund and P2,400.00 for item C-1-c (wages of employees in the City Mayor's office, including those attached to the Office of the City Auditor), which amount shall cover the overdraft already incurred and expenses estimated up to June 30, 1958;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;



2,400.00 - for wages of the employees of the Office of the City Mayor including those attached to the Office of the City Auditor (item C-1-c);

"CARRIED, Unanimously."


