RESOLUTION NO. 55

"WHEREAS, the Chief of Police, this City, in a letter to this Board dated April 28, 1958, requested the purchase of 12 firearms (Police-type weapons) for official use of the Police Department;

"WHEREAS, the said request for the purchase of firearms by the Chief of Police has been motivated by an unnumbered Provincial Circular issued by the Office of the Executive Secretary, Malacañang, Manila, urging local governments to set aside funds to cover the purchase price of police-type weapons, in view of standing instructions from the General Headquarters of the Philippine Constabulary recalling all Army-type weapons loaned to non-military agencies;

"WHEREAS, the Police Department, this City, has 14 Army-type firearms loaned from the PC; and

"WHEREAS, the moment these firearms will be recalled by the PC the Police Force will then be underarmed;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Larrazabal and Tan, Jr.;


"RESOLVED, as it is hereby resolved, to appropriate the amount of P1,500.00 from out of the salary savings of any and all the departments of the city government, to be made available for the purchase of firearms, the specifications as follows:

- 10 - .38 Cal. Police Positive revolvers, Smith & Wesson;
- 2 - 12 Gauge Riot Guns


