RESOLUTION NO. 56

"WHEREAS, a contract for a road right-of-way has been entered into by and between the Honorable City Mayor in behalf of the city government and the land owner, Mrs. Amparo Kangleon;

"WHEREAS, the parcel of land over which the contract has been made, had been utilized by the city government a long time already and which is now occupied by Bonifacio Extension;

"WHEREAS, Mrs. Kangleon is now claiming for the payment of her land alleged, a portion of Lot No. 1388 covered by Transfer Certificate of Title No. 1492 with an area of 233 square meters and another 253 square meters of the same lot; and

"WHEREAS, the appraisal committee has appraised the said lot at ₱6.00 per square meter or an aggregate amount of ₱3,516.00 will be needed to pay the said claim; and

"WHEREAS, there is no source at present from where the city can get funds to pay the said claim;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Larrazabal and Penserga;

CARRIED, Unanimously.


