RESOLUTION NO. 59

"WHEREAS, a representative of the Director of Posts, Manila, has been sent to Ormoc City to secure a donation of an appropriate lot from the city government, wherein the Bureau of Posts can construct a building for the post office at this city;

"WHEREAS, it may be noted that the post office is now housed in a rented private building which is quite a distance from the city hall and other city government offices; and

"WHEREAS, it is the desire of this Board to have the post office building erected as near as possible to the city government office buildings for the convenience of the departmental offices of the city;


"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to donate the site or lot situated at Corner C. Aviles and Wm. Bryant Sts. (the remaining portion of the lot previously donated to the Bureau of Telecommunications) adjacent to the present public dispensary building, to the Bureau of Posts so that a post office building for Ormoc City can be constructed thereon, hereby authorizing the City Mayor of Ormoc, to execute a Deed of Donation of the lot aforementioned, in favor of the Bureau of Posts, Manila;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Director of Posts, Manila; the City Treasurer and the City Auditor, both of Ormoc City.

"CARRIED, Unanimously."


